What is ADOPT A STUDENT?

Adopting a student for just \$25 per month is a wonderful way to help change the life of a student in need. Sponsoring a student will allow them uninterrupted participation in one dance class per week.

How does sponsorship work?

When you make your tax deductible gift, your contribution is matched by Action Dance dollar for dollar. Your contribution is then pooled with contributions from other sponsors into the general fund. The Action Dance School then delegates these funds to ensure that each student is allotted an appropriate amount based on financial need.

The goal of sponsorship is to allow as many students as possible to step into a dance class. Each student has a different level of need, which means that your sponsorship may help just one student or many students for one month or years.

Why adopt a student through Action Dance?

Action Dance's student sponsorship program creates real, lasting change for children, teenagers and young adults. Sponsoring a student will help them off the couch or off the street. Students in dance class will experience fun, friendships, confidence, creativity and health.

Who manages the contributions?

The Action Dance School Board oversees the general fund and ensures that one hundred percent of all contributions are directly used to enroll underprivileged students in the classes. Every student must fill out an application for financial assistance before receiving money from the fund. Each application is reviewed by the board and judged for financial need.

\$500/one time	\$1000	One student, in classes all season
