COMPANY PHOTOSHOOT

Lisa has very reasonable prices, quality work and an excellent track record with our students. Picture forms can be picked up from the reception desk. One form per costume/dance. Payment will be made directly to Lisa Hystek Photography on the day of the photoshoot. **Please fill out order form (s) prior to photo session.** Each dancer must have the completed order form at the time of session. For multiple orders, please inform the bookkeeper and they can collect a single check or credit card number. Have all the separate order forms filled out. Individual or solo pictures will not be taken without payment. We are sorry, but no parents permitted in the dance room during photo sessions. Anna Vega has been selected as Action Dance's ambassador to Lisa Hystek photography to help everything run smoothly. Please give her your utmost respect on photoshoot day.

AUDITION UPDATE

Auditions will be held for the 2010-2011 Action Dance Performing Company on **April 16-19, 2010**. The audition fee is \$10 for the first company and \$7 for each additional company (select companies excluded). **Registration for auditions is required by Wed April 14!** Make-up auditions will be held June 21-24, 2010 an additional \$5 audition fee is required per company for make-up auditions.

Audition results will be posted after the make-up auditions. The Company Agreement and first company payments will be due by July 18. No big changes are planned for the company agreement or company structure. The agreement will be available to view in late March.
